We have implemented the following measures to mitigate the risk of modern slavery:

- Supplier Code of Conduct: We require our suppliers and business partners to confirm adherence to ethical standards, including a commitment to preventing modern slavery.
- Internal Training: Our staff are trained to identify potential red flags related to modern slavery and unethical recruitment practices.
- Whistleblowing Policy: We maintain an open and accessible reporting process, encouraging employees, contractors, and partners to raise concerns without fear of retaliation.

5. Risk Assessment and Management

While the risk of modern slavery within our own operations is low, we recognise higher risks may exist in:

- The extended supply chains of some clients
- Subcontracted or outsourced services
- Offshore operations and remote contractor engagements

We assess these risks and engage with clients and partners to ensure they operate responsibly. Where concerns arise, we investigate immediately and take appropriate action.

6. Monitoring and Review

We will review and update this statement annually. As part of our ongoing commitment, we are exploring additional ways to strengthen our due diligence and supplier engagement processes, including:

- Periodic audits of high-risk placements
- Enhanced onboarding checks for contractors
- Partnering with industry initiatives that promote ethical recruitment
